- 2. The number of non-public and private school employees and volunteers who have been rejected for employment (we interpret this to mean "be denied clearance for employment") on the basis of their criminal histories: The answer to this question is none. So far, no prospective employee or volunteer of a non-public or private school has been denied clearance for employment.
- 3. The name and address of all non-public and private schools that have had employees or volunteers rejected for employment (we interpret this to mean "be denied clearance for employment") on the basis of their criminal histories: The answer to this question is none. So far, no prospective employee or volunteer of a non-public or private school has been denied clearance for employment.
- 4. Documents and records all non-public school and private employees and volunteers rejected for employment (we interpret this to mean "be denied clearance for employment") on the basis of their criminal histories: There are no documents that satisfy this request. So far, no prospective employee or volunteer of a non-public or private school has been denied clearance for employment.
- 5. Since July 1, 2007, broken out by year if possible, the number of days from the time a request is submitted until the decision regarding clearance or denial is made (we interpret this to mean the date a "complete" fingerprint application is received, meaning application, payment and fingerprints). The average number of days for all of the fingerprints submitted for non-public schools is less than one day (.37 days).
- 6. The information you requested in paragraph 6 has been forwarded to the Office for Non-Public Schools for a response. We do not maintain that information in OSPRA.
